This release extends and applies to, and also covers and includes, all unknown, unforeseen, unanticipated and unsuspected injuries, damages, loss and liability, and the consequences thereof, as well as those now disclosed and known to exist. The provisions of any state, federal, local, or territorial law or statute providing substance that releases shall not extend to claims, demands, injuries, or damages which are unknown or unsuspected to exist at this time, to the person executing such release, are hereby expressly waived.

I hereby agree on behalf of my heirs, executor, administrators, and assigns, to indemnify, Children's Healthcare of Atlanta, Argonne Parades, WSB-TV and its officers, board, and employees, jointly and severally and hold harmless Children's Healthcare of Atlanta, Argonne Parades and WSB-TV from any and all actions, causes of actions, claims and demands for, upon or by reason of any damage, loss or injury, which hereafter may be sustained by participating in the Christmas parade.
